BHN will not air or display my street address or phone number. BHN and its licensees also may run advertising and other promotional material in connection with the Video.
3. I represent that: (a) I own or have the appropriate rights for BHN and its licensees to use the Video, including any music in the video, (b) the Video and BHN's use do not and will not violate any law or infringe any rights of any party, including, any copyright and/or rights of privacy or publicity, or defame anyone, (c) BHN is not required to obtain any permission or release from, or pay any money or other compensation to, any third party in order to use the video, (d) I understand that I may not submit any video created by third parties, including but not limited to parts of television shows, movies, and the like, and (e) I have full right, power and authority to enter into this agreement and to grant all of the permissions stated above.
4. I will indemnify and hold harmless BHN and its owners, affiliates, licensees, officers, employees and representatives against any claims, damages, judgments, liabilities costs and/or expenses (including reasonable attorneys' fees and costs) as a result of any actual or alleged breach of my warranties and representations as set forth in Section 3 above.
5. This agreement constitutes the entire understanding between me and BHN with respect to this subject matter, and supersedes any prior agreements, representations or understandings, whether written or oral, with respect to this subject matter; it cannot be modified except in a writing signed by an authorized BHN representative.
